WORKER'S COMPENSATION

Risk Management Services self insures the Workers' Compensation Program for the State of Georgia. The program is administered through a contract with Key Risk Management Services, a third party administrator.

The Workers' Compensation Program provides for monetary supplements for absences from work as well as medical care through the Amerisys Managed Care Organization and other costs associated with job related injuries.

A part of the Workers' Compensation Program is "Georgia Focus", which is a three-tiered approach to the safety, care and recovery of employees. The program places focus on taking care of employees.

- Tier 1 is a proactive approach to the safety of employees through job hazard analysis, education and corrective actions to hazardous conditions
- Tier 2 is a managed approach to the care of employees in the event of an injury. Through the Amerisys Managed Care Organization, employees who have suffered a job related injury are provided with timely and effective medical care. Timely reporting of injuries by the supervisor ensures injured workers are receiving prompt care and benefits to which they are entitled.
- Tier 3 is a return to work team approach that focuses on an employee's ability as opposed to disability. This approach enables the employee to return to work sooner and within their medical restrictions







Which accidents should I report?

All of them – make no determination of fault – report them within 48 hrs.

Am I covered in my personal vehicle?

If you are doing your official duties at the time, you are covered under the Ga Tort Claims Act.

Can I be sued personally?

You may not be personally sued under the Ga Tort Claims Act. State employees have immunity while performing their official duties.

Am I covered in a rental vehicle?

Yes, but only while doing the business of the state.

Does the state carry medical payments or uninsured/underinsured motorist coverage?

No. We provide Liability Coverage to state employees driving on state business and in the course and scope of their employment

If I'm in my personal vehicle and doing the state's business, will you pay for the damage to my vehicle?

NO

Can subcontractors drive state vehicles?

We provide no coverage for subcontractors.

Does the DOAS Automobile Physical Damage Agreement provide coverage for damage to rental vehicles?

No, you need to request and purchase a separate "Loss Damage Waiver" from the vehicle rental company. However, if you rent a passenger vehicle under a Statewide "Automotive Rental" contract utilizing the current contract ID number, then the Loss Damage Waiver is automatically included in the vehicle rental fee.
