Question:	Is the Zep contract located on Team Georgia marketplace?

Question:	Do we have to buy products from Zep if we would rather buy form General Services Agency (GSA)?
Answer:	State entities are not allowed to purchase off of the GSA Contract.
Question:	Do any of the products on this contract duplicate any of the certified cleaning products/chemicals from GCI. If so which take precedence?
Answer:	If they do, the Georgia Correctional Industries (GCI) contract takes precedence.
Question:	Does the Zep contract SWC 90793 replace the Ecolab dishwashing chemical contract that expired?
Answer:	Yes. This contract has been in existence since December 30, 2008.
Question:	Sometimes our billing is wrong. We make purchases based on GA pricing, but then we get a higher rate. What can be done on your end to ensure that the pricing will be updated in your system?
Answer:	It was recently identified that approximately 3% of our items were not billed correctly. Zep has rectified the issue and will make the necessary account adjustments.
Question:	Our customer ID is NA2039350. Why are we getting charged shipping on all orders?
Answer:	This issue has been corrected and credits issued. If you have any invoicing questions, please refer them to <u>Georgia.State@zep.com</u> for resolution.
Question:	When ordering online, will tax and shipping be taken off the invoice?
Answer:	Yes.

Question:	Does Zep supply secondary container labels?
Answer:	Yes Zep will supply the appropriate amount of secondary container labels.
Question:	Does Zep provide any signage for product dilution systems?
Answer:	Yes, Zep will provide the appropriate signage for the account.
Question:	Can Zep assist us in implementing a "Green Cleaning Program"?
Answer:	Yes, Zep has both CIMS certified Trainers and LEED AP personnel to assist in the development a "Green Cleaning Program"
Question:	Can Zep perform an analysis of our current purchases and identify cost savings opportunities?
Answer:	Yes, Zep will perform a Total Cost of Ownership (TCO) survey to identify the opportunities
Question:	Does Zep manufacture its products?
