As stated in the July 29, 2021, *Buyers' Digest*, the Georgia Department of Administrative Services, State Purchasing Division, announces the roll out of the new statewide contract (SWC) **Natural Gas – Interruptible Delivery Service (SWC 99999-001-SPD0000192)** with **Gas South, LLC and Texican Industrial Energy Marketing**. The effective date of this contract is **November 1, 2021**, through October 31, 2023. This contract will be a **Mandatory Contract**. This new contract replaces the existing statewide contract, Natural Gas Interruptible Delivery (99999-001-SPD0000099-0002), upon the effective date.
