The Georgia Department of Administrative Services, State Purchasing Division, announces the roll out of the new statewide contract (SWC) for **New Tires and Retread Tires (SWC 99999-001-SPD0000203)** with **Bridgestone Americas Tire Operations LLC, Michelin North America, Inc., The Goodyear Tire & Rubber Company, and Continental Tire the Americas, LLC**. The effective date of this contract is **July 1, 2022** and goes through June 30, 2024. This contract will be a **Mandatory Contract**. This new contract will replace the existing statewide contract, Tires, Tubes and Retread Tires (99999-001-SPD0000116), upon the effective date.

**State entities must make all necessary adjustments since not all categories under the new SWC will be served by the same suppliers under the existing SWC. Under the new SWC and in accordance with O.C.G.A. 50-5-60.3, any authorized user of a state entity who requires truck tires on non-steering axles and the rim size for these tires is greater than 16-inches, the authorized user must purchase retread tires to fulfill this requirement.**
